REQUIREMENTS FOR ARTICLES COMPOSITION

Please, adhere to rules of preparation, performance and design of the article for **Kherson State University Herald. Series “Legal Sciences”** Authors manuscripts have to be performed in accordance with state standards and comply with requirements of the Resolution of Higher Attestation Commission of Ukraine (VAK) No 7-05/1 dated 15.01.2003: “...to accept only scientific articles, which have such necessary elements: *problem statement in general terms and its connection with important scientific or practical tasks; analysis of recent research and publications, which initiated the solution of the problem and author bases on, the allocation of previously unresolved parts of the general problem, the article is devoted to; formation of article’s goals (task statement); presentation of the main materials with a full substantiation of received results; conclusions from the research and prospects for further investigation in this area*”(Bulletin of VAK of Ukraine, No 1, 2003).

1. Requirements for manuscript composition

1.1. Page A4. Page parameters: up and bottom fields – 20 mm, left – 30 mm, right – 15 mm; font – Times new roman, 14; line spacing – 1,5.

1.2. References to the sources should be made in the text in square brackets, indicating the pages numbers of the source. For example, [1, p. 12]

1.3. Bibliography description of references must contain authors’ surname and initials, research title, city and publication year, publishing press, amount of edition pages.

1.4. The author's notes are made at the end of the pages using * as a sign of the footnote.

2. The volume of the article is up to 20 pages; scientific report, summaries – up to 3 pages.

3. 3. References are at the end of the article in the order of citation of the sources, taking into account the National Standard of Ukraine **DSTU 8302: 2015 “Information and documentation. Bibliographic reference. General principles and rules of composition”**.

4. The article has to include number and name of a specialty, UDC, summaries and key words in Ukrainian, Russian and English (the volume of English abstract should be at least **1800 characters including keywords**), article translation is performed in English. Mentioned elements are obligatory place as follows:

CONDITIONS OF PAYMENT

The publication fee is **580 UAH** (*up to 12 pages, inclusively*). If the article exceeds the indicated volume, you have to pay 50 UAH for each additional page. The publication fee covers the costs, associated with articles editing, page planning and printing of the journal as well as postal mail to authors.

Editorial board carries out plagiarism test and review (type - internal and anonymous). After review the authors receive the payments details of publication fee or article is sent back for improvement.

To publish an article in **No 6**, it is necessary before **January 25, 2019 (inclusively)**:
